**ARTICLES OF INCORPORATION  
OF  
SPRING GARDEN DELI, INC.**

The undersigned subscriber to these Articles of Incorporation, being a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

**ARTICLE I**

The name of this corporation shall be **SPRING GARDEN DELI, INC.**

**ARTICLE II**

The corporation may engage in any activity or business permitted under the laws of the United States and of this state.

**ARTICLE III**

The capital stock of this corporation shall consist of 100 shares of common stock. Each share of common stock shall have a \$1.00 par value and shall be entitled to one vote. Consideration to be paid for each shall be payable in lawful money of the United States or any property, labor or services at just valuation to be fixed by the stockholders. Stock shall be subject to pre-emptive rights.

**ARTICLE IV**

The amount of capital with which this corporation will begin business is \$100.00.

**ARTICLE V**

This corporation is to exist perpetually.

## **ARTICLE VI**

The initial street address of the principal office of this corporation in the State of Florida is 817 Helen Avenue, DeLand, Florida 32720. The common stockholders may from time to time move the principal office to any other address in Florida and the corporation shall have the right and power to transact business and have offices and agencies in such other places as the common stockholders may from time to time authorize.

## **ARTICLE VII**

The registered office of this corporation shall be initially 817 Helen Avenue, DeLand, Florida 32720, and its initial registered agent shall be Dawn M. Salvaggio. Such registered office or agency may be redesignated by a majority of the stockholders entitled to vote and in such case, the redesignation shall be effective upon filing such redesignation in the form and manner required by law.


