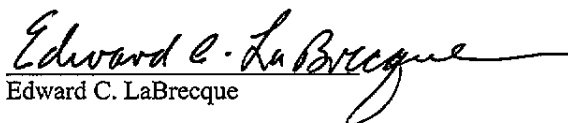

BYLAWS

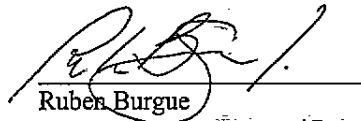

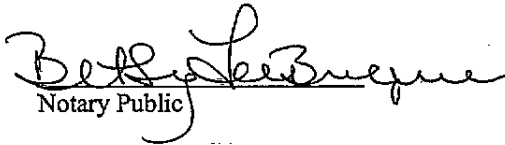
