ARTICLES OF AMENDMENT OF BURGUE MARKETING CORPORATION

THE UNDERSIGNED, RUBEN BURGUE, JR., being the President and Secretary of BURGUE MARKETING CORPORATION, a Florida corporation (the "Corporation"), does hereby certify that the following Amendment to the Articles of Incorporation of the Corporation was approved by the Stockholders of said Corporation on the <u>12</u> day of February, 2007, at a duly called meeting of the Stockholders and Directors of the Corporation.

The Articles of Incorporation of BURGUE MARKETING CORPORATION are hereby amended as follows:

1. The Article regarding the Capital Stock of the Corporation is deleted and the following is inserted in lieu thereof:

ARTICLE III

CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any one time is 10,000 shares of common stock, of which 9,997 shares shall be non-voting and 3 shares shall be voting, all having a par value of \$.01 per share. Each former share shall be converted to 10 shares as a consequence thereof.

- 2. All amendments included herein were adopted February 12, 2007, pursuant to Section 607.1004, F.S., and there is no discrepancy between the Corporation's Articles of Incorporation as theretofore amended other than the inclusion of these amendments and the omission of matters of historical interest.
- 3. This Amendment has been approved by the consent of Shareholders of the Corporation who are entitled to vote the 12 day of February, 2007.
- 4. This Amendment shall be effective upon its filing with the Secretary of State, State of Florida.
