ARTICLE I - NAME

The name of the corporation formed pursuant to these Articles of Incorporation is Brettin Appraisal Services, Inc.

ARTICLE II - DURATION

The corporation shall exist perpetually, commencing on December 1, 2000.

ARTICLE III - PURPOSE

The corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under Chapter 607, *Florida Statutes*.

ARTICLE IV - CAPITAL STOCK

The corporation is authorized to issue 1,000 shares of no par value common stock.
