ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

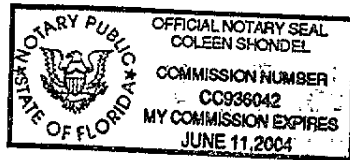
stockholders sign a written statement manifesting their intention that a certain amendment to these Articles of Incorporation be made.
