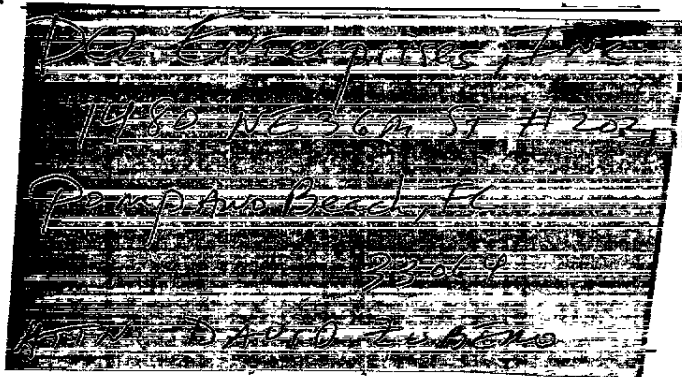

ARTICLE 1 CORPORATE NAME

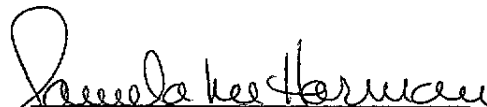

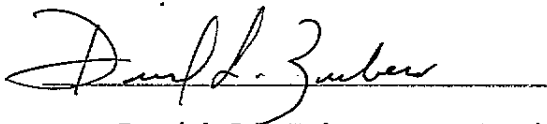
