ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of this corporation is MOTOR HOME SALES, INC., and its principal office and mailing address is:

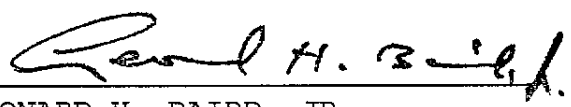
