Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:

First: Amendments adopted:

The Director and President of the corporation (Article 5) and Resident Agent of the corporation (Article 6) is changed from Brodzik, Krista Gates to Gates, Krista S., with address of 1003 S.
