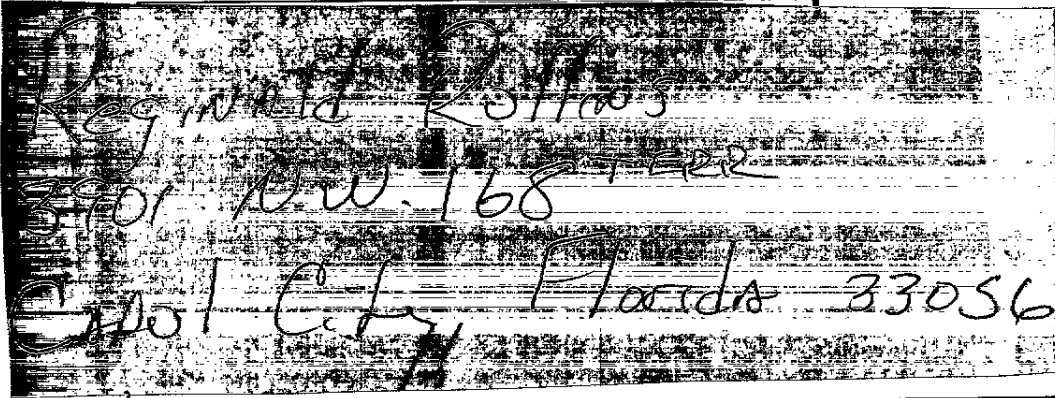

ARTICLE OF INCORPORATION

Unda Presha Inc.

ARTICLE ONE

The name of the corporation is Unda Presha Inc.  
(The corporation's name must end with one of the following: Company, Corporation, Incorporated or an abbreviation thereof.)

ARTICLE TWO

The period of its duration is perpetual.  
(May be for a number of years or until a specific date.)

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.  
(Specific purposes may be stated.)

ARTICLE FOUR

The aggregate number of shares which the corporation shall have authority to issue is 10 of the par value of dollars (\$100.00) each.  
(Shares may be of no par value.)

ARTICLE FIVE

The corporation will not commence business until it has received for the issuance of shares consideration of the value of \$1000.00 consisting of money, labor done or property actually received.  
(May be any sum of not less than \$1,000.)

ARTICLE SIX

The street address of its initial registered office is 3901 N.W. 16<sup>th</sup> TERR., Florida, and the name of its initial registered agent at such address is Reginald Bollins.  
(Use the street, building or rural route address of the registered office; a post office box number is not sufficient.)

ARTICLE SEVEN

The number of directors constituting the initial board of directors is 1, and the names and addresses of the person or persons who are to serve as directors until the first annual meeting of the shareholders or until their successors are elected and qualified are:
