ARTICLE I

Name and Principal Office

The name of the corporation shall be Will Knot Di Productions, Inc. The principal office and mailing address for the corporation shall be 10 5th St. N., Suite 204, St. Petersburg, Florida 33701.

ARTICLE II

Term of Existence

The corporation shall have perpetual existence, commencing on December 5, 2000.

ARTICLE III

<u>Purpose</u>

The general purpose of the corporation shall be to transact any and all lawful business for which corporations may be incorporated under the Florida Business Corporation Act.

ARTICLE IV

Powers
