ARTICLES OF INCORPORATION ALAN MOSLEY & ASSOCIATES, INC.

SECRETARION Florida The undersigned, acting as Incorporator of a corporation under the Business Corporation Act, adopts the following Articles of Incorporation fo corporation.

- 1. The name of this corporation is ALAN MOSLEY & NAME. EFFECTIVE DATE ASSOCIATES, INC.
- PRINCIPAL OFFICE/MAILING ADDRESS: The principal office of the corporation is 2755 Laten Lane, Jacksonville, FL 32216. The mailing address of the corporation is 2755 Laten Lane, Jacksonville, FL 32216.
- 3. SHARES. This corporation is authorized to issue 1000 shares, all of one class, at \$1.00 par value.

6. PREEMPTIVE RIGHTS. Each shareholder of this corporation shall have the first right to purchase shares (and securities convertible into shares) of any class, kind or series of stock in this corporation, that may from time to time be issued (whether or not presently authorized), including shares from the treasury of the corporation, in the ratio that the number of shares he holds at the time of issue bears to the total number of shares by any shareholder who does not exercise it and

pay for the shares preempted within thirty (30) days of receipt of a notice in writing from the corporation, stating the prices, terms and conditions of the issue of shares, and inviting him to exercise his preemptive rights. This right may also be waived by affirmative written waiver submitted by the shareholder to the corporation within thirty (30) days of receipt of notice from the corporation.

- 7. PURPOSE. The purpose is to engage in any activities or business permitted under the laws of the United States and Florida.
- 8. DURATION. The effective date of commencement of corporate existence shall be January 2, 2001. The period of its duration is perpetual.
- 9. AMENDMENT OF ARTICLES. This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.
