ARTICLE I.

NAME

The Name of the Corporation is PLA EXPORT EDITORES, INC.

ARTICLE II.

TERM OF CORPORATE EXISTENCE

ARTICLE VI.

PRINCIPAL OFFICE

ARTICLE VII.

REGISTERED OFFICE AND AGENT

ARTICLE VIII.

DIRECTORS AND OFFICERS
