ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF THE PARLOR OF SOUTH FLORIDA, INCORPORATED



Pursuant to the provisions of Section 607.1006. Florida Statutes, this corporation adopts the following Articles of Amendment to its Articles of Incorporation:
