ARTICLES OF INCORPORATION
OF BROADBAND SECTOR, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I -- NAME

The name of this corporation shall be: BROADBAND SECTOR, INC.

ARTICLE II -- PURPOSE
