Enclosed is my check for \$163.75 which includes, \$150.00 for the filing of my 2002 Uniform Business Report, \$8.75 for Certification Status, and \$5.00 for Campaign Financing Contribution. I ask that the late fee of \$400.00 be waived for the following reasons:
