ARTICLE VIII. TERM OF EXISTENCE

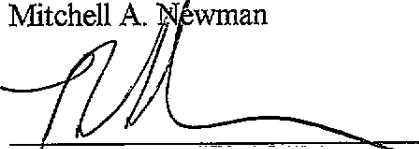
