ARTICLE I – NAME

The name of this Corporation is A-Plus Title and Escrow Inc.





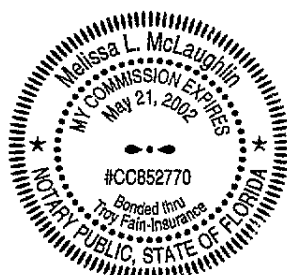
