**NAME**

The name of this corporation is ***Genius, Inc.***

**ARTICLE II**

**PURPOSE**

This corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is ***100,000 shares of common stock of 1.00 Dollar per share par value.***

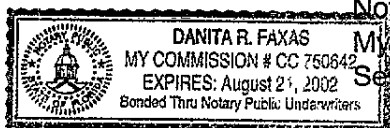


