

ARTICLE ONE

The name of the corporation is **TRIUMPH EXPEDIENT EMPLOYMENT, INC.** The principal address of the corporation is: 12330 SW 2nd St., Plantation, FL 33325


The Board of Directors is empowered to make, alter or repeal the Bylaws of the corporation without restriction of their powers conferred by statute.
