Articles of Incorporation

Pursuant to Chapters 607 and 621 F.S.,

Article I

Establishment of Corporate Name

A Corporation is established under the established, fictitious name of The Advocate Outfitter, Corporation.

Article II

Principal Business Address

The Advocate Outfitter, Corporation. is located at 1038 Shady Bridge Road, Lloyd, Jefferson County, Florida 32337. The mailing address of the Corporation is 1699 Apalachee Parkway #494, Tallahassee, Florida 32301.

Article III

Corporation Purpose
