ARTICLE VI. DIRECTORS

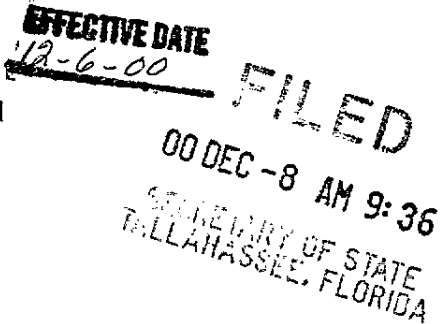

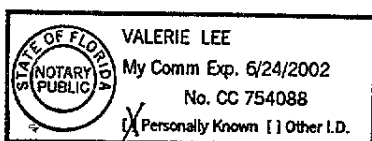
