ARTICLES OF INCORPORATION OF KID CRAFT, INC.

OD OR STANDIOS

ARTICLE I - NAME

The name of this Corporation is KID CRAFT, INC.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any activity or business permitted under the laws of the United States and Florida.
