The corporate officers requested that I write you concerning the attached copy of a notice received that their corporation will be dissolved effective January 01, 2001, if an annual payment is not received by your office prior to May 1st and later prior to September 12th.

The officers are confused, in that, the corporation was formed effective December 11, 2000. The officers were led to believe that the attorney who formed and filed the corporate papers that the fee paid to the attorney and the Department of State related to the calendar year 2001. There was no indication from the attorneys office that forming a corporation December 11th would be good for only 20 days and then another \$150. would be due for the calendar year 2001.

If known the corporation would have been formed on January 02, 2001.

In view of these circumstances, the officers are respectfully requesting that you accept the enclosed check of \$ 150. for the calendar year 2001 and abate the proposed assessment for late payment.
