# ARTICLES OF INCORPORATION OF TANJA, INC.

I, the undersigned, hereby subscribe to, acknowledge and file the following Articles of Incorporation, for the purpose of creating a corporation under the Laws of the State of Florida.

### ARTICLE ! - NAME

The name of this corporation is: TANJA, INC. , a Florida corporation.

Any director of this corporation who is also a director or officer of such corporation, who it is so interested may be counted in determining the existence of a quorum at any meeting of the Board of Directors of this corporation.
