Articles of Incorporation Lotta Liquors, Inc.

The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE I-Name

The name of the Corporation is Lotta Liquers, Inc.

ARTICLE II - Principal Office and Mailing Address of the corporation

The address of the principal office of the corporation is Lotta Liquors, Inc., 571 Grand Cayman Cir

Lakeland, Fla. 33803, and its mailing address is the same.

ARTICLE III - Commencement and Duration

The corporation is to commence its corporate existence effective immediately, and shall exist perpetually thereafter until dissolved according to law.
