The undersigned, being of legal age and competent to contract, for the purpose of organizing a corporation pursuant to the laws of the State of Florida, does hereby adopt the following Articles of Incorporation, and does hereby agree and certify as follows:

#### ARTICLE I NAME

<u>01-01-0</u>

The name of this Corporation shall be LAKE SHORE ACRES MOTEL, INC.

### ARTICLE II COMMENCEMENT OF CORPORATE EXISTENCE

This Corporation shall commence corporate existence on January 1, 2001, and shall have perpetual existence unless sooner dissolved according to law.
