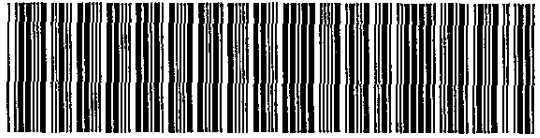


RE: Closing Corporation
