# **ARTICLES OF INCORPORATION**

<u>OF</u>

### INTERNATIONAL SERVICES AND PRODUCTS, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

#### ARTICLE I

The name of the corporation is: International Services and Products, Inc.

The corporation will engage in any activity or business permitted under the laws of the United States and the State of Florida.
