ARTICLES OF INCORPORATION  
OF

MEDICAL INTEGRATED TECHNOLOGIES INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is MEDICAL INTEGRATED TECHNOLOGIES INC.

ARTICLE II

The existence of the corporation shall begin on the date of its incorporation by the State of Florida.

ARTICLE III

The street address of the principal office of the Corporation is 14700 Sunset Lane, Southwest Ranches, Florida 33330.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is One Hundred Thousand (100,000), all of which shall be Common Shares, no par value.
