ARTICLES OF INCORPORATION OF

MEDICAL INTEGRATED TECHNOLOGIES INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being an aftirate ersem does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

The name of the corporation ("Corporation") is MEDICAL INTEGRATED TECHNOLOGIES INC.

ARTICLE II

The existence of the corporation shall begin on the date of its incorporation by the State of Florida.

ARTICLE III
