ARTICLE I - NAME

The name of this corporation is: CONSOLIDATED BILLING & COLLECTIONS, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

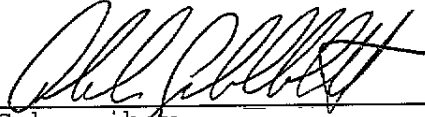

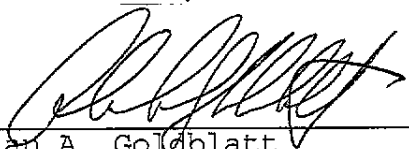
