Dear Sir or Madam:

This letter is in response to the fees for reinstatement pursuant to being Administratively Dissolved for not properly filing a 2001 Uniform Business Report. For reasons that follow, it is our position that reasonable cause existed and that it was not willful neglect for not filing the Uniform Business Report timely and that therefore the fees should be abated.

We are a new Florida corporation. We were incorporated on December 15, 2000. We did not begin operating the corporation until 2001 and therefore no business activity took place in the year 2000 at all. As a new corporation we were not skilled in all of the legalities required of Florida corporations. Further, since we did no business in 2000 at all, we did not research all of the requirements because we assumed that as a start up corporation no state filing fees or forms would be due.

However, we did perform diligently what we believed to be all of the necessary duties of a startup corporation. We obtained a federal ID number, we filed timely IRS "S" elections, we filed timely 2000 federal and Florida corporate income tax returns, and we have set up Florida employment accounts for our payroll. We did not however, prepare the 2001 Uniform Business Report.

To our defense, please note that we did not receive in the mail a package containing the Uniform Business Report, and therefore did not become apprised of our obligation to complete the form until recently. However, upon learning that we should have completed

this report, we are now trying to rectify the problem by completing the necessary form and paying the fee.

Therefore and in light of the foregoing reasons, we respectfully request that you abate the penalties for untimely filing the Uniform Business Report. To demonstrate both our willingness to be compliant and that we run our business with ordinary care and business prudence, we have retained a CPA firm to help us perform our filings in the future, in a timely basis. Thus we feel that we have used reasonably diligent means to ensure that all of our filing obligations will be properly taken care of in the future.
