ARTICLES OF INCORPORATION

OF

MEDROL, INC.

The undersigned, for the purpose of forming a corporation, adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is Medrol, Inc., and its address is 140 Via D Este #804, Delray Beach, Florida, 33445.

DURATION

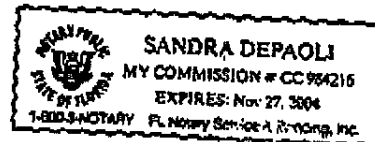
