**ARTICLE I**

### **Initial Board of Directors**



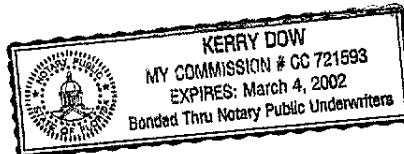
