# AMENDMENT AND RESTATEMENT OF THE ARTICLES OF INCORPORATION OF MICHAEL M. INGRAM, P.A.

WHEREAS, MICHAEL M. INGRAM, P.A. (the "Corporation"), was formed as a professional corporation under the laws of the State of Florida effective January 1, 2001, with the sole business purpose of the practice of law and all other activities permitted under applicable law; and

INGRAM, administered by Katherine Phillips Ingram and Mary Mayhew Ingram (collectively, the "Personal Representative") pursuant to Letters of Administration issued on or about June 14, 2011, by the Thirteenth Judicial Circuit Court, in and for Hillsborough County, Florida, Probate Division, in that certain probate case numbered 11-CP-001096; and

WHEREAS, the Personal Representative deems it in the best interests of the Corporation and of the estate to provide for continuing existence of the Corporation as a corporation with the purpose of conducting any and all lawful business, in accordance with the requirements of Chapters 607 and 621 Florida Statutes.

THEREFORE, the Personal Representative, voting the shares of the Corporation on behalf of the estate of Michael M. Ingram in accordance with the provisions of Section 607.1003, Florida Statutes, which number of votes is sufficient for approval, does hereby amend and restate the Articles of Incorporation of the Corporation pursuant to the provisions of Sections 607.1006 and 607.1007, Florida Statutes, as follows:

Article I - Name of Corporation

### Article III - Business and Purpose

The general purpose for which this corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the Business Corporation Act of the State of Florida, and any amendments thereto, and in connection therewith, this corporation shall have and may exercise any and all powers conferred from time to time by law upon corporations formed under such Act.

# Article IV - Capital Stock

This corporation shall have the right to change such registered office and such registered agent from time to time, as provided by law.

### Article VII- Board of Directors

The Board of Directors of this corporation shall consist of not less than one (1), nor more than fifteen (15) members, the exact number of directors to be fixed from time to time by the stockholders or the Bylaws. The business and affairs of this corporation shall be managed by the Board of Directors, which may exercise all such powers of this corporation and do all such lawful acts and things as are not by law directed or required to be exercised or done only by the stockholders.
