**ARTICLES OF INCORPORATION
OF**

ARTICLE I - NAME

The name of this corporation is KENNEL REALTY, INC.

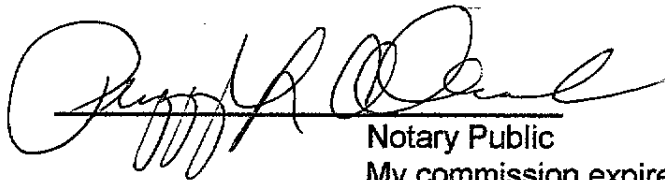
