ARTICLES OF INCORPORATION
OF

I, the undersigned subscriber to these Articles of Incorporation, being duly licensed to practice Medicine under the laws of the State of Florida, adopts these articles to form a corporation under the Professional Service Corporation and Limited Liability Company Act, F.S. Chapter 621, and other laws of the State of Florida.

ARTICLE I - Name:

The name of the Professional Service corporation is **YAKUB A. POTHIAWALA, MD, PA.**

ARTICLE II - Principal Office:

The principal office and mailing address of this corporation is 3865 Northdale Boulevard, Tampa, Florida 33624. The Directors from time to time may designate such other address and place for principal office of the Corporation as they deem appropriate.

ARTICLE III - Purpose:

The professional service corporation is formed to engage in every phase and aspect of the practice of medicine. 
