

ARTICLE I - NAME

The name of this Corporation shall be W&K CHATOFF CORP.



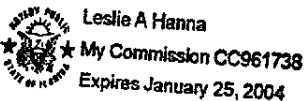
