ARTICLES OF INCORPORATION OF A & T BERRY, INC.

I, the undersigned, hereby make the within Articles of Incorporation for the purpose of becoming incorporated and being a corporation under and by virtue of the laws of the State of Florida pertaining to the Florida Business Corporation Act, under the following proposed charter:

ARTICLE I - NAME/ADDRESS

The name of this corporation shall be **A & T BERRY, INC**., and it's business shall be carried on in the State of Florida connected with the aforesaid purpose. And in addition, to engage in any other business or businesses permitted under the laws of the United States and the State of Florida and such other states and foreign countries as may be agreed upon, and it's principal place of business shall be 2180 North Hercules Ave., Clearwater, Florida 33763 or such other place as from time to time is designated.

ARTICLE II - PURPOSE

This corporation shall be authorized and permitted to engage in any activity or business permitted under the laws of the United States and the State of Florida. This corporation's primary business shall be the laundering and dry cleaning of clothing throughout Florida, the United States and Internationally or any other act or thing incidental or pertinent to or growing out of or in anywise connected thereto.

ARTICLE III - CAPITAL STOCK

The total number of shares that may be issued by the corporation is 500 shares of common shares, with a par value of one dollar per share, which shares may be issued in fractional shares and may be in whole or in part canceled and reissued at any time in compliance with the by-laws of this corporation. Said shares shall be paid for in such manner as the Board of Directors may provide and approve, whether in cash, services or property.

ARTICLE IV - DURATION

This corporation shall have perpetual existence unless sooner terminated by operation of law or voluntary dissolution in the manner prescribed by law.

ARTICLE V - OFFICERS AND DIRECTORS

The business and affairs of this corporation shall be conducted and managed by a Board of Directors of not less than two members who shall be elected annually by the shareholders of the corporation at such time and place as may be fixed by the by-laws, Shareholder's Agreement, or by resolution of the Board of Directors, and who shall hold office until their successors shall be elected and qualified.
