
ARTICLE X. INDEMNIFICATION



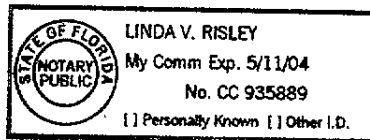


