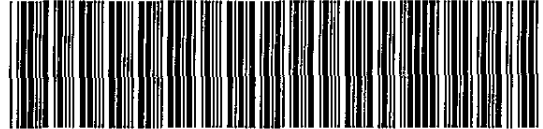

Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following Articles of Amendment to its Articles of Incorporation.

FIRST: Amendment adopted: Article I of the Articles of Incorporation of ProTek COOL Coatings, Inc. is hereby amended as follows:

ARTICLE I

The name of this corporation shall be Armor Coat Spray on Siding, Inc. The mailing address and the street address of the principal office of this corporation are 4171 Pace Lane, Pace, Florida 32571.
