The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the Corporation is: **STITCHES R US, INC.**

ARTICLE II: DURATION

The existence of the Corporation shall commence on the date of subscription and acknowledgment. The duration of the Corporation is perpetual.
