OF

1. The name of the corporation is **Confidential Search, Inc.**
2. The purpose for which this corporation is organized is to transact any and all business for which corporations may be incorporated under Chapter 607, Florida Statutes.
3. The initial business of the corporation shall include, but not be limited to, the pre-employment screening, tenant and employment background screening, mortgage credit reporting.
4. The corporation shall have the authority to issue 3000 shares of common stock, in one class only, each with a par value of \$1.00.
5. The initial registered office of the company shall be **169 Tequesta Drive, Suite 21E, in the Village of Tequesta, Florida 33469**, which address shall be the same address of the corporation's principal office.
6. The registered agent of the company shall be **Alan Neese**, an officer of the corporation whose address is **18529 Lake Bend Drive in the Town of Jupiter and Florida 33458**. *I accept the duties of registered agent.*

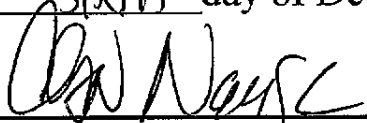
The number of directors may be raised or lowered by amendment of the bylaws of the corporation but shall in no case be less than one.

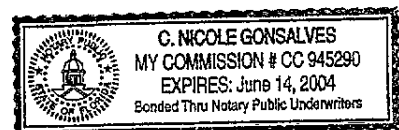
