**Articles of Incorporation
of
Paddy Garibaldi's Tampa, Inc.**

THE UNDERSIGNED, acting as the sole incorporator of Paddy Garibaldi's Tampa, Inc. ("Corporation") under the Florida Business Corporation Act, Chapter 607, Florida Statutes, as hereafter amended and modified (the "FBCA"), hereby adopts the following Articles of Incorporation for the Corporation:

ARTICLE I

Name

The name of the Corporation is:

ARTICLE II

Business and Activities

The Corporation may, and is authorized to, engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE III

Shares

The total number of shares which the Corporation shall have the authority to issue shall be ONE THOUSAND (1,000) shares of Common Stock having a par value of \$.001 per share (the "Common Stock").

ARTICLE IV

Initial Board of Directors

The number of Directors constituting the initial Board of Directors of the Corporation is one (1). The number of Directors may be increased or decreased from time to time in the manner provided for in the bylaws, but in no event shall the number of Directors be less than one (1).
