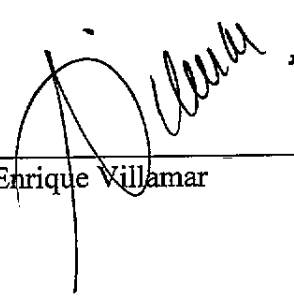
### **ARTICLE IX - INDEMNIFICATION**

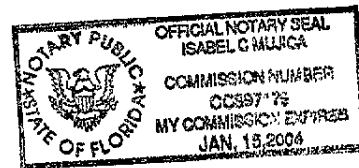
