ARTICLES OF INCORPORATION  
of

BARBERVILLE AUTOMOTIVE REPAIR, INC.

ARTICLE I  
CORPORATE NAME

The name of this corporation is BARBERVILLE AUTOMOTIVE  
REPAIR, INC.

ARTICLE II  
NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by  
this Corporation is to engage in any and all business per-  
mitted under the laws of the State of Florida.

ARTICLE III  
CAPITOL STOCK

The maximum number of shares of stock that this corpo-  
ration is authorized to issue and have outstanding at any  
one time is one hundred (100) shares of common stock having  
a par value of \$10.00 per share.

ARTICLE IV  
TERM OF EXISTENCE

This corporation shall have perpetual existence, com-  
mencing on the filing of these Articles.

ARTICLE V  
REGISTERED AGENT AND INITIAL REGISTERED OFFICE

initial registered office of this corporation in the State

BOARD OF DIRECTORS

This corporation shall have one (1) Director initially. The number of Directors may be increase or decreased from time to time by Bylaws adopted by the Stockholders, but shall never be less than one.

ARTICLE VII

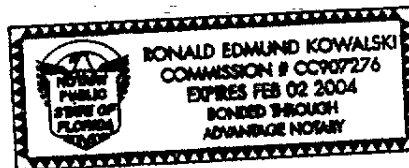
