Articles of Incorporation of ReSci Technologies, Corp.

Article One:

The name of the corporation is ReSci Technologies, Corp.

Article Two:

The period of its duration is perpetual.

Article Three:

The purpose for which the corporation is organized is the transaction of all lawful business for which corporations may be incorporated under the Florida Corporation Act.

Article Four:

The aggregate number of shares which the corporation shall have authority to issue is twenty thousand (20,000) of the par value of one dollar (\$1.00) each.

Article Five:

The corporation will not commence business until it has received for the issuance of shares, consideration of the value of five hundred dollars (\$500.00) consisting of money, labor done of property actually received. Upon issuance of shares, said shall be divided as follows,


