
ARTICLES OF DISSOLUTION  
PURSUANT TO SECTION 607.1403  
OF THE FLORIDA BUSINESS CORPORATION ACT  
OF  
TELECONTRACT SERVICES, INC.

Pursuant to the provisions of Sections 607.1402 and 607.1403 of the Florida Business Corporation Act, the undersigned Corporation adopts the following Articles of Dissolution for the purpose of dissolving the Corporation:

Article I. The name of the Corporation is: Telecontract Services, Inc.

Article II. The Board of Directors recommended to the Shareholders as of November 28, 2001 that the Corporation be dissolved effective November 29, 2001 and a resolution to that effect was adopted by the shareholders of the Corporation as of November 28, 2001, the number of votes cast or consents given for dissolution being sufficient for approval.
