

*The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.*

**ARTICLE 1- NAME**

The name of the Corporation in MAR CO (hereinafter, "Corporation")

**ARTICLE 2- PRINCIPAL OFFICE**

The initial address of the principal office and mailing address of the Corporation is 9709 52<sup>nd</sup> Terrace North, St. Petersburg, FL 33708 USA.

**ARTICLE 3 COMMENCEMENT OF CORPORATE EXISTENCE**

The corporation's existence will commence **December 12, 2000**; provided however, that such date is within five business days prior to the date these Articles of Incorporation are filed by the Department of State of the State of Florida.
