The undersigned, for purposes of forming a corporation under the Finda Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation shall be DESIGN DALTON, INC. The principal place of business of this corporation shall be 180 Santa Clara Dr #13, Naples, Florida 34104.

ARTICLE II. NATURE OF BUSINESS
